## ELECTRICITY RATES

### **Time-of-Use (TOU)** (November 1 to April 30)

Rates apply when account has a smart meter

Off-peak \$0.083 per kWh\*\*

(Weekdays 7 p.m. – 7 a.m. & Weekends & Holidays)

Mid-peak \$0.128 per kWh\*\*

(Weekdays 11 a.m. – 5 p.m.)

On-peak \$0.175 per kWh\*\*

(Weekdays 7 a.m. – 11 a.m. & 5 p.m. – 7 p.m.)

### **Tiered** (November 1 to April 30)

Rates apply when account has a non-smart meter.

First 1000 kWh per month \$0.099 per kWh\*\*

Additional kWh per month \$0.116 per kWh\*\*

Time-of-Use and Tiered electricity rates are set by the Ontario Energy Board every 6 months – additional information available at [www.ontarioenergyboard.ca](http://www.ontarioenergyboard.ca). If you buy your electricity through a contract with an Electricity Retailer, you pay their price plus the Provincial Global Adjustment.

Line & Transformation Connection \$0.0023 per kWh\*

Network Service \$0.0074 per kWh\*

Off-peak \$0.083 per kWh\*\*

(Weekdays 7 p.m. – 7 a.m. & Weekends & Holidays)

Mid-peak \$0.128 per kWh\*\*

(Weekdays 11 a.m. – 5 p.m.)

On-peak \$0.175 per kWh\*\*

(Weekdays 7 a.m. – 11 a.m. & 5 p.m. – 7 p.m.)

##### **Tiered** (November 1 to April 30)

Rates apply when account has a non-smart meter.

First 750 kWh per month \$0.099 per kWh\*\*

Additional kWh per month \$0.116 per kWh\*\*

Time-of-Use and Tiered electricity rates are set by the Ontario Energy Board every 6 months – additional information available at [www.ontarioenergyboard.ca](http://www.ontarioenergyboard.ca). If you buy your electricity through a contract with an Electricity Retailer, you pay their price plus the Provincial Global Adjustment.
