## RESIDENTIAL

Effective January 1, 2021

### Electricity Rates

#### **Time-of-Use (TOU)** (November 1 to April 30)

Rates apply when account has a smart meter.

Off-peak (Weekdays 7 p.m. – 7 a.m. & Weekends & Holidays)	\$0.085 per kWh**
Mid-peak (Weekdays 11 a.m. – 5 p.m.)	\$0.119 per kWh**
On-peak (Weekdays 7 a.m. – 11 a.m. & 5 p.m. – 7 p.m.)	\$0.176 per kWh**

#### **Tiered** (November 1 to April 30)

First 1000 kWh per month	\$0.101 per kWh**
Additional kWh per month	\$0.118 per kWh**

Time-of-Use and Tiered electricity rates are set by the Ontario Energy Board every 6 months – additional information available at [www.ontarioenergyboard.ca](http://www.ontarioenergyboard.ca). If you buy your electricity through a contract with an Electricity Retailer, you pay their price plus the Provincial Global Adjustment.

Low Voltage Charge	\$0.0003 per kWh
OEB Regulated Rate Riders	\$0.001 per kWh
Line & Transformation Connection	\$0.0025 per kWh*
Network Service	\$0.0071 per kWh*

## SMALL COMMERCIAL Effective January 1, 2021

*Rates for general service non-residential accounts with an average monthly demand of less than 50 kW and total annual usage below 250,000 kWh*

### Electricity Rates

#### **Time-of-Use (TOU)** (November 1 to April 30)

Rates apply when account has a smart meter.

Off-peak \$0.085 per kWh\*\*

(Weekdays 7 p.m. – 7 a.m. & Weekends & Holidays)

Mid-peak \$0.119 per kWh\*\*

(Weekdays 11 a.m. – 5 p.m.)

On-peak \$0.176 per kWh\*\*

(Weekdays 7 a.m. – 11 a.m. & 5 p.m. – 7 p.m.)

#### **Tiered** (November 1 to April 30)

First 750 kWh per month \$0.101 per kWh\*\*

Additional kWh per month \$0.118 per kWh\*\*

If you buy your electricity through a contract with an Electricity Retailer, you pay their price plus the Provincial Global Adjustment.

Distribution Service Charge \$34.28 per month

Distribution Usage Charge \$0.0177 per kWh

OEB Regulated Rate Riders \$(0.0011) per kWh

Line & Transformation Connection \$0.0023 per kWh\*

Network Service \$0.0066 per kWh\*
