

You may be eligible to receive an 8% rebate on your electricity bill effective January 1, 2017 under the Ontario Rebate for Electricity Consumers Act, 2016. If your account meets any of the eligibility criteria below, please check off all boxes that apply, sign and date the form. Once completed, please return it to Waterloo North Hydro by email to billing@wnhydro.com, in-person or by mail.

If you qualify for the rebate, we will retroactively credit your account (as applicable) to consumption effective January 1, 2017 or to a maximum of two years from the date you provided us with the completed self-declaration form, if submitted after January 1, 2019.

Eligibility for the 8% rebate

To be eligible to receive the 8% rebate on your electricity bill, you must qualify under at least ONE of the following criteria:

(Please check all that apply to your account)

- Annual demand for electricity of 50 kilowatts or less;
- Annual consumption of 250,000 kilowatt hours of electricity or less;
- You carry on a business that is a farming business for the purposes of the Farm Registration and Farm Organizations Funding Act, 1993, and you hold a valid registration number assigned under that Act or your obligation to file a farming business registration form was waived pursuant to an order made under subsection 22 (6) of that Act;
- Your account relates to one of the following:
 - (i) a dwelling,
 - (ii) a property, within the meaning of the Condominium Act, 1998,
 - (iii) a residential complex, within the meaning of subsection 2 (1) of the Residential Tenancies Act, 2006, without regard to section 5 of that Act, or
 - (iv) a property that includes one or more housing units and that is owned or leased by a co-operative within the meaning of the Co-operative Corporations Act;
- Your account includes one or more non-traditional residential units, such as a hotel/motel, where the unit must be the full-time, permanent residence of the occupant. Also, the occupant pays for the right of exclusive possession. Exclusive possession means that the occupant cannot be evicted without some sort of formal process.

I, as a signing officer of the organization, confirm that my account includes a non-traditional unit (e.g. hotel/motel) where at least one customer is using a unit as a full-time, permanent residence. I agree to advise Waterloo North Hydro in writing if my account ceases to qualify for the 8% rebate and acknowledge that failure to do so will lead to the requirement to reimburse any overpayment to Waterloo North Hydro. Any penalty or action resulting from false declaration shall be borne by the account/customer.
